



## TIME BUILDING & BLOCK RENTAL RATE AGREEMENT

**Time Building and Block Rental Agreement:** Any and all aircraft owned, leased or otherwise operated, and offered for rental by ANGEL AVIATION, INC (ANGEL AVIATION).

### TIME BUILDING RENTAL

#### I. Flight Operations

- a) Time Building is a price-reduced program designed for CROSS COUNTRY FLYING ONLY and applies when pre-paying for a minimum of 10 hours of flight time.
- b) Prior to first flight a check-out at the current hourly rental rate with instructor is required.
- c) Touch & go's, pattern work, and flight training are strictly PROHIBITED.
- d) Each Time Building flight must be greater than 4.0 hours when flying in Arizona.
- e) Each Time Building flight must be greater than 2.0 hours when flying in Alaska.
- f) ANGEL AVIATION reserves the right to restrict, prohibit, and reschedule aircraft rentals as needed.

#### II. Payment

- a) FULL PAYMENT for Time Building will be based on the FLIGHT HOBBS meter and is to be paid PRIOR to conducting the flight.
- b) If Time Building Block is not completed in the appropriate timeframe and a refund is requested, any billed flight time will revert to the current hourly rental rate.
- c) Fuel is reimbursed with original fuel receipt at the base airport/s current self-serve pump price.

### BLOCK RENTAL

#### I. Flight Operations

- a) Block Rental is a price-reduced program and applies when pre-paying for a minimum of 10 hours flight time.
- b) Prior to first flight a check-out at the current hourly rental rate with instructor is required.

- c) **Block Rental time must be used within 1 calendar month. If Block Rental time is not completed within 1 calendar month and a refund is requested, any billed flight time will revert to the current hourly rental rate.**
- d) **ANGEL AVIATION reserves the right to restrict, prohibit, and reschedule aircraft rentals as needed.**

### II. Payment

- a) **FULL PAYMENT for Block Rate will be based on the FLIGHT HOBBS meter and is to be paid PRIOR to conducting the flight.**
- b) **If Block Rate time is not completed within 1 calendar month and a refund is requested, any billed flight time will revert to the current hourly rental rate.**

### III. Liability for Damage to Aircraft

- a) **Renter agrees to pay ANGEL AVIATION for aircraft recovery, any damage or loss to a rental aircraft, including but not limited to loss of use, due to Renters negligence or misuse or any other cause occurring during the period the aircraft is in the possession and care of the Renter. If the Renter has rental aircraft insurance, ANGEL AVIATION will collect any sums due directly from the insurance carrier.**

By his/her signature on this agreement, Renter agrees to all the terms and conditions contained herein and that all such terms and conditions shall apply to any and all aircraft rental periods.
